On 23 February 2019, the Assembly of the *European Inter-University Centre for Human Rights and Democratisation (EIUC)*, based in Venice and consisting of 38 universities within the 28 Member States of the European Union (EU), decided to amend its Statute and also change the name of this association to [Global Campus of Human Rights](#). This is the last and decisive step in a longer process of transforming the network of universities from a European into a global one.
